- 20-21 Century Isms: Fascism, Communism, Jihadism
- Antisemitism in All Isms: Mein Kampf, Iran, Hamas Charter and More
- Mass Exposure to These Ideologies → Genocide and Genocidal Terror

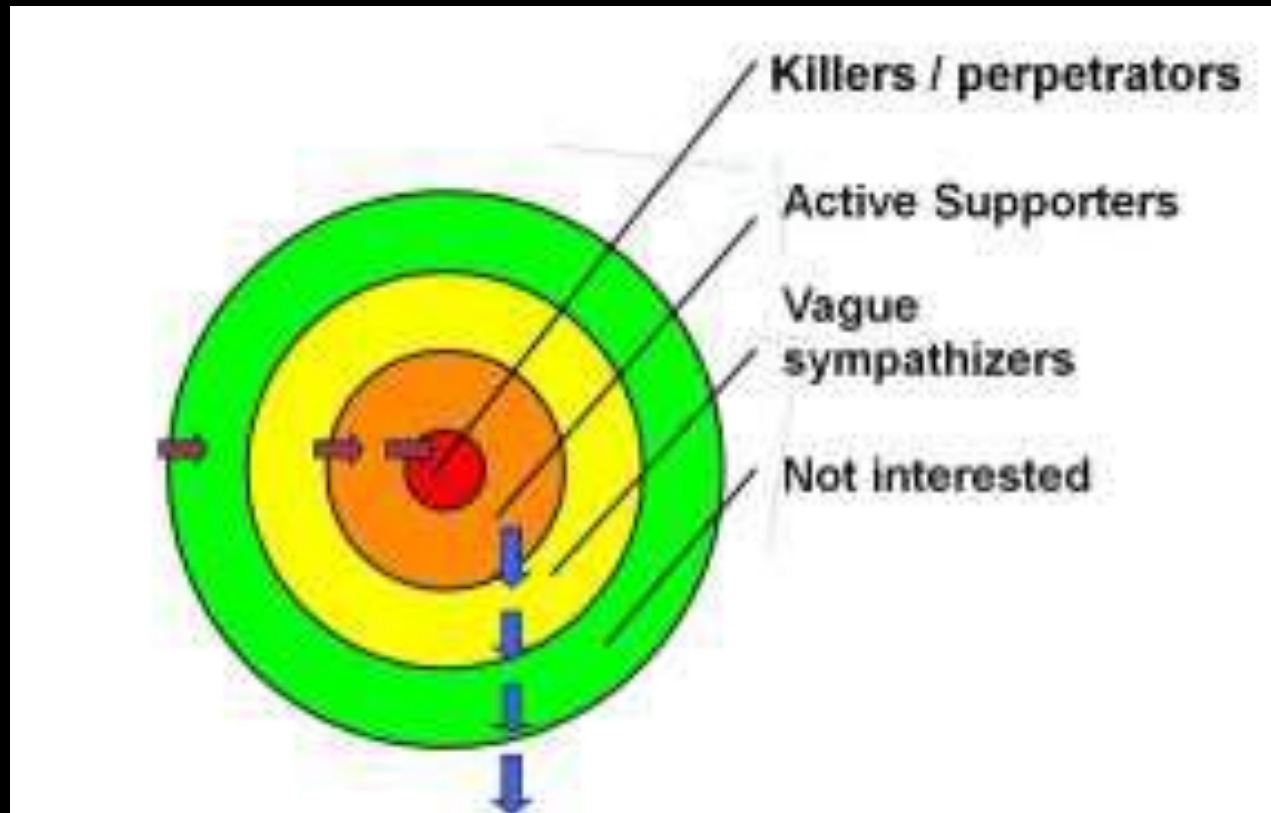
Ethical Poverty No. 2: Indoctrination and Incitement

- Early Warning Signs
- The 3 Ds: Dehumanization, Demonization, Delegitimization... and Glorification of Terror
- Core Document: UN Genocide Convention (1948):
Genocide and Its Incitement: Crimes Against
Humanity
- Mass Population-wide Cradle-to-Grave Exposure: Role
of Textbooks and Social Media

Ethical Poverty No. 3: Bystander Indifference

- Enables Genocide
- What Should Be the Role and Responsibilities of Bystanders, e.g. UN Aid Programs, for Preventing Indoctrination and Incitement?

The Precautionary Principle (PP)

- Environmental Medicine's Gift to Genocide Prevention
- Dangers of Ignoring Early Warning Signs
- Advances Locus of Intervention from Proof of Intent *After* The Event to Predict and Prevent *Before* the Event

New Responsibilities:

Steps Forward:

- Apply PP to Predict and Prevent Genocide and Genocidal Terror
- Apply PP by Using Moral Agency to Overcome Bystander Indifference
- ZT4I: Zero Tolerance for Incitement
- Denazification as a Model
- Stop Pay for Slay
- Stop Funding for War Curricula in UNRWA Summer Camps
- Positive Deviance: Mobilize Abraham Accords
